The Trustees above named have agreed to act as trustees of the trust, hereby established and constituted.

All the above trustees shall be the life trustees and further trustees if appointed shall hold office, for a period of five years, from the date of appointment. Trustees may resign their office after due and prior notice in writing addressed to the Chairman of the Board.

The Life trustees shall be entitled to determine from time to time, the number of members of the Board of trustees and nominate the trustees other than life trustees.

"Trustees for Life" shall be entitled to nominate their successor to the "Office of Trustee" and in the event of a vacancy arising in the "Office of a Trustee for life" due to failure to nominate the successor, the remaining Life Trustees shall nominate any members of the family of the life trustee causing the vacancy.

The Chairman of the Board of trustee shall hold office as Chairman for a period of five years and shall be eligible for re-appointment. The Board may appoint one of themselves, as Chairman of the Board and assign him such functions as the Board deems fit.


The Board of Trustees shall be competent to transact all and every business if not less than three trustees are present.

Neither a vacancy nor a defect in the constitution of trust Board shall invalidate any of the proceedings of the Board of trustees.

Assets of the Trust:

The assets of the trust shall consist of

- 1) A sum of Rs.10,000/- paid by the Founder Trustee as an endowment for the trust and all other contributions as the founder and other persons may make from time to time.
- 2) Such sum or assets as may be contributed gifted, donated, or bequeathed by any person, firm, company or trusts, institutions or organizations in this country or abroad.
- 3) Any grants as contribution that may be made by the Central Government or State Government or Local Authority or Public Body or any institution whatsoever.
- 4) All the interest and income and accretions arising out of the assets of the trust.
- 5) All assets movable and immovable purchased or acquired out of the property of the trust.
- 6) All investments and realization of the funds and assets of the trust.
- 7) All moneys, assets, claims and rights, which by any means may become the property of the Trust.



Objects of the Trust:


The Objects for which the trust is created and established are:

- a. To establish, maintain and manage schools, colleges and other educational Institutions both residential and non-residential and libraries for the advancement of knowledge in any subject or language.
- b. To establish, maintain and manage Institutions for training Teachers.
- c. To establish, maintain and manage Institutions for imparting Technical know-how in handicraft, industries, engineering and other allied subjects.
- d. To create, establish, control and manage other Trusts or other Institutions or corporate bodies for the purpose of carrying on or continuing to carry on the activities which the Trust is authorized to carry on and in furtherance of the same donate, convey and vest in such Trust or Institutions or Bodies such properties and assets and other materials of the Trust on such conditions as may be stipulated by the Trust from time to time.
- e. To render financial and other help to Educational Institutions, students hostels and orphanages, to award scholarships or stipends to students to enable them to prosecute their studies and to award prizes to students who show high proficiency in any subject.
- f. To establish, maintain and manage boarding houses or hostels for students studying in schools, colleges or other Educational Institutions including Technical Training Institutions.
- g. To promote research for the advancement of Science and Technology.
- h. To produce, print, publish, circulate and distribute books, periodicals, journals, pamphlets and other materials for advancing the cause of Education.
- i. To provide necessary forum and other necessary facilities for holding public lectures, seminars and discussions on matters connected with Education.
- j. To do all such acts, deeds, things in addition to and in furtherance of the above purposes and in the advancement of any other Educational object of public utility not motivated for profit.
- k. Each of the above objects of the trust shall be deemed to be separate and independent object of the trust and will be carried out without any distinction of caste, creed or religion.
- l. The trust is not indented to do business with profit motive.




POWERS OF TRUSTEES:


- 1) The Trustees shall have the management of all the affairs and business of the Trust and Board of Trustees shall have full power and authority to do all acts or things in relation to the management and administration of the affairs of the Trust and its assets and transactions. The Trustees shall have the power to call in and convert into cash the Trust properties realize all or any of the securities and investments and reinvest them in such manner as it authorized herein.
- 2) The Trustees shall receive and hold the funds and properties belonging to the Trust, and the Funds of the Trust shall vest in the Trustees who shall administer the same in accordance with and for the purpose set out in these presents.
- 3) The Trustees shall have power to borrow from time to time for the purpose of the Trust such sum or sums of money at such interest for such period and on such terms with or without security, movable or immovable as the Trustees may think fit and to secure payment thereof by mortgage or by bond, promissory notes, bills, hundies and other negotiable securities or by issue of debentures. The Trustees shall have power to accept contributions in money or property either by way of addition to the Trust Funds, generally as for any one or more of the specified objects of the Trust in either case such contribution shall be dealt with either as capital or as income according to the directions of the donors at the time of gift.
- 4) The trustees shall have power to acquire hold the dispose off assets movable or immovable properties of every description for the furtherance of the objects of the Trust.
- 5) All amounts that are not immediately required for the purpose of the trust, shall from time to time to be invested and kept in the names of the trust or in accordance with the provisions of Sec 13(I(d)) read with Sec 11(5) of the Income Tax Act, 1961 or any other provisions of the Act as in force in India.
 - i. As fixed deposits or other deposits with any scheduled bank or post office Savings Bank.
 - ii. By Investment in Trustee securities, as funds authorized for investment trustees under the Indian Trust Act or rules made hereunder.



- iii. By the purchase, subscription or otherwise of any security though such investment may not be a trustee security and without prejudice to the generality of the foregoing in the purchase, subscription or acquisition of shares debentures or other securities issued by any Municipality, Public Body or of any Corporation, Company as Persons.
 - iv. By advancing money as loans to any person, firm or company on such terms and securities as may be approved by the Trustees, provided that such persons, firm or company is not one in which the founders of the Trust or the Trustees have any interest.
 - v. The Trustees may at any time enter into any arrangement for obtaining any grant or contributions from the Government of India, Government of the States or any Government Authorities or Institutions any conditions as to the constitution of the trust or any regulation, direction or control over the administration of the Trust or by vesting the power of appointment removal and re-appointment of one or more trustees by such Government and Governments or authorities and all such arrangements and conditions so agreed upon, shall be deemed if so, expressed in such arrangement or agreement to be part of and to be incorporated as part of this Trust and where so expressed may modify or over rule any provision of these presents.
- 6) The Trustees shall have power of appointment of all employees under the trust and in particular of the staff and to fix the scales of pay of all staff or other employees and to grant increments and to suspend dismiss or terminate the appointment of any of the staff and other employees.
- 7) The Trustees shall make rules for the purpose administering the Trust and shall have the power to vary or amend the said rules.
- 8) The Trustees shall to be bound personally to administer or manage the fund and such administration and management may subject to the control of the trustees be delegated by them to such person or persons as may be approved by them.



- 9) No Trustee shall be liable for any loss not attributable to his own dishonestly or of commission by him of an act amounting to a breach of Trust and in particular he shall not be made liable for failure to take any providing against any breach as alleged breach of trust committed by the Co-trustees.
- 10) Every Trustee shall be indemnified out of the funds of the Trust in respect of any loss arising from on contingent upon any investment made of any of the amounts of the fund unless, such loss shall have been occasioned by his own negligence and also every Trustee shall be indemnified out of the funds against all proceedings, suits, claims, costs, damages and expenses occasioned by any claim any connection with the fund in the execution of the Trust created by these presents as in the exercise if any powers authorities or discretion vested in them pursuant to these presents.
- 11) Each of the Trustees will on vacating office do and execute all such acts, documents, matters and things as shall be necessary for the administration of the Trust funds and such other purposes of the trust as the Board may direct.
- 12) The Trustees shall maintain true and correct accounts of all Trust amounts and of all the income and investment thereof and all outgoings and expenses.
- 13) The Year of account of the Trust shall be the Financial Year (i.e. April to March) Board of Trustees may vary this for any valid reason.
- 14) The Trustees shall in each year prepare in a report setting out of the accounts showing the income expenses thereof of the preceding year not later than 6 months from the end of the preceding year of account together with the list of the investments belonging to the Trust at the cost price and at the approximate market value of the said investments at that date.
- 15) The accounts of the Trust shall be audited every year by a Chartered Accountant, who may be appointed for the purpose, by the Board of Trustees.



- 16) All expenses of the management of the fund shall be incurred by the trustees at their discretion and shall be paid out of the funds and shall be a first charge there on.
- 17) a. The trustees shall meet as often as they may deem fit but shall meet a least once in every three months.
- b. The Trustees shall exercise all their powers by majority voting.
- c. A meeting of the Board of Trustees may be convened by the Chairman or under his directions by the Secretary. Any two trustees may require a meeting to be convened and there upon the Chairman or the Secretary shall convene a meeting of the Trustees.
- d. If at a meeting of the Trustees the Chairman is not present within 15 minutes of the commencement of the meeting or if there is no Chairman, Trustees present, shall elect one of their own bodies to be the Chairman of the said meeting.
- e. In the event of equality of votes, the Chairman or in the absence, the Chairman of the meeting shall have a casting vote.
- 18) Any resolution of the Trustees for the time being holding office shall be binding as a resolution duly passed at a meeting duly convened and held.
- 19) The Trustees may by a resolution open one or more banking accounts for the trust in the name of the Trust.
- 20) a. The Trustees may empower any two or more of their body to operate the banking account or accounts of the Trust.
- b. The Trustees may by resolution, authorize any person or persons not being a Trustee to operate on the banking accounts of the Trust.




- 21) The Trustees may delegate to one or more of their body the followings powers subject to such conditions or limitations as they may deem fit from time to time and at any time vary, withdraw or revoke any of the powers, so delegated.
- a.to make investments of the moneys of the fund.
- b.to demand, claim and receive any moneys due to the trust from any person and to grant bona fide receipts, thereof.
- c.to institute or defend and conduct all legal proceedings for and on behalf of the Trust in respect of any matter relating to the Trust and for that purpose to engage and instruct lawyers and to sign vakalaths, pleadings and other documents necessary or usual for the said purpose.
- 22) Trustees may at any time and from time to time appoint any person as secretary of the Trust on such terms and conditions as they may deem fit and vest in him, such powers and duties as they may deem fit.
- 23) Trustees may from time to time and at any time make rules not inconsistent with the Trust Deed for the conduct of the business of the Trust and for the regulation of their own meetings and May from time to time vary, amend on revoke the same.

24) Amendment of the Trust Deed

The terms of the Trust Deed except relating to the objects of the trust may at any time and from time to time be amended in the manner following namely. By a resolution passed by three fourths of members present at a meeting of the Board of Trustees or by resolution or in writing signed by all Trustees for the time being holding office.

- 25) The Head and Central Office of the Trust shall be situated at present at a rented premises **No.1/216, Thalambur Road, Navalur, Thirupporur Taluk, Kancheepuram District, Pin - 603103.** or such other place as the Trustees may Decide from time to time.



- 26) The trustees shall not utilize the funds of the trust for any purpose other than the objects of the trust and no portion of it would be distributed in any manner to the trustees or persons as defined in Sec 13(1)(c) of the Income Tax Act.
- 27) In the event of the dissolution or winding up of the trust, all the assets of the trust together with the investments shall be transferred to, amalgamated or merged with another trust having same or similar objects.
- 28) This Trust shall be irrevocable.
- 29) The Activities of the Trust would be confined to the territory of India.
- 30) Not more than 5% of the income of the Trust would be applied for any religious purposes or given to any religious institutions.

The Trust has no Immovable or Movable Property on the date of Registration.
