

(i) Age should not be less than 25 years.

(iii) Mentally & Physically fit person.

(iv) Experienced person in Social Project.

(6) **Management of Trust:-**

(I) The general management of the trust for the purpose of managing the affairs and properties and carrying out aims & objectives of the Trust shall be vested in the Board of Trustees.

(II) The Board of Trustees shall have one managing Trustee. The first Managing Trustee will be **Gyan Chand Jain**. The First Managing Trustee shall also be known as founder President/settler of the trust.

(III) The founder Trustee shall have the power to Corporate any other Trustee or Trustees at any time or from time to time for the convenient & Proper conduct of the affairs of the Trust.

(IV) All deeds and documents necessary for the purpose of the Trust shall be executed in the name of the managing Trustee & the Trust will be represented by the managing Trustee or as resolved by Board of Trustees.

(V) The founder Trustee **Gyan Chand Jain** Shall be the first President of the Trust who will hold office of the President of the Trust.

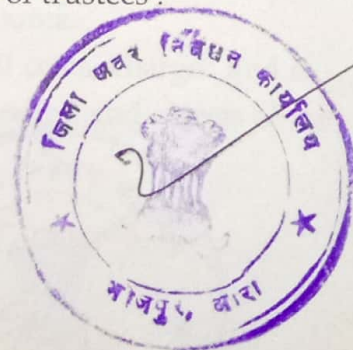
(VI) Thereafter the existing trustees shall but one of then as the President of the Board of Trustees.

(VII) The Trustee may appoint, constitute one or more committee constituted of one or more persons for carring one or more or more objects of the Trust.

(VIII) The Trustee may with a majority vote, dismiss any committee or constitute or reconstitute the same as they thinks proper in thir discretion for the benefit of the trust.

(IX) All matters will be guided by majority of votes & in case of equality of votes, the President shall have a second or casting vote. four Trustees shall form a quoram for meeting of trustees.

(X) The Trustees may from time to time and whenever necessary frame schemes and Rules and Regulation.

(XI) The existing Trustees may appoint one or more Trustees at their discretion from time to time but in any case the total number of the Trustees including the New Trustees to the appointed shall not exceed fifteen (15).

(XII) The name of Trust shall not be changed by any authority in any circumstances.

(XIII) The Trustees may accept any donation, loan, contribution in cash or kind or otherwise from founder or any other member of his family or any other person or persons in public firm company societies, bodies, co-operation charitable Trust or institution or association for and on behalf of the Trust or from the govt. or semi Govt. bodies, Banks national and international funding agencies and for the furtherance of the objects of the Trust or for any one or more of them upon such terms and conditions, as they may in their absolute discretion think fit and which are not inconsistent with the objects of the Trust.

(XIV) Any conveyance mortgage, re-conveyance, lease or any other deed document or assurance, whatever may be signed, executed and registered by the President.

(XV) The Trustees shall utilies/ spend the Trust's fund after deduction of all expense of the management of the trust and the Trust Property, if any be spent for the benefit of the public at large without distinction of any caste, creed or religion for all or any of the objects of the trust.

(XVI) The Trustees shall be entitled from time to time to appoint officials, servants, workers etc. with or without remuneration and on such terms and conditions as they may think proper to function under the authority and control of the Trustees, and for the furtherance of the different schemes, objects and works of the Trust.

(XVII) The Trustees shall be entitled to open Trust accounts with any Bank or post office for the purpose of keeping and transaction of the fund and money of the Trust and to operate such accounts including overdraft accounts and to give instruction to the Bank/ Post Office in relation to the opening and mode of operation of such accounts.

(XVIII) The Trustees shall be entitled to pay all costs, charges and expenses incidental to the management, administration and objects of the Trust.

(XIX) The Trustees shall be entitled to organise cultrural Programmes, fate Mela, exhibition and sale counters etc. to mobilise fund for the furtherance of the objects of the Trust.

(XX) The Trustees shall be bound to keep clear and accounts of the Trust property and funds at all responsible time.

(XXI) The Trustees shall be entitled to receive any remuneration as trustees.

(XXII) The Trust shall have a advisory committee national level to advise the Trustees on the activities and programmes of the Trust. The strength of advisory committee shall not exceed 100 (Hundred) at a given time this committee shall function under direct control of the Trust and the President. The Trust shall act as ex-officio member of the said advisory committee.

(XXIII) The Trustees shall be entitled to take over the management of any charitable public or private institution or organisation on such terms they may think fit and may manage the same. The Board of Trustees shall for the purpose of awarding prizes, awards, scholarship study loans, etc. appoint one or more committees consisting of not less than three members to act as panel of Judges, consisting of eminent Personalities from any of the following categories:-

- (A) Retired Judge,
- (B) Govt. official/Ex. official the rank of Gazatted officer/Secretary.
- (C) Prominent Personality /Social Worker/artist/ scientist of national repute.
- (D) Prominent scholarly University lecturer.
- (E) Army/ Retd. army personnel not below the Rank of left. Col.
- (F) Any person whom 2/3 mojority of Trustees agree for inclusion.

(XXV) The accounts of the Trust shall be closed on 31st March every year.

(XXVI) Two Trustees at a meeting shall form quorum for any meeting of the Trustees.

(XXVII) In absence of President of the Trust and in absence of any clear cut directive from his side regarding the conduct of the meet ing, the Trustees Present shall choose one of themselves to be the President of such meeting .

(XXVIII) Notices of the meeting of the Trustee and all communication may be sent to the Trustees at their address registered for the time, in the record of the trust.

(XXIX) A resolution, in writing circulated amongst all the Trustees and passed by a majority of the Trustees shall be as valid and effectual as if it had been passed at a meeting of the Trustees duly called and concerned.

(XXX) A Trustee who is unable to be present at a meeting of the Trust may send his views on the agenda in Writing and such expression of opinion, shall be taken to be his vote on the matter concerned.

(XXXI) The minutes of the proceeding of every meeting of the Trustees shall be enforced in a book to be kept for that purpose and signed by the chairman/President of such meeting at the next meeting.

A person shall cease to be a trustees in andor the following circumstances:-

- (a) If he died' or
- (b) If he becomes bankrupt: or
- (c) If he becomes insance or otherwise becomes incapable to act or ;
- (d) If he resigns his office, or ;
- (e) If he is requested to resign by two third of the remaining Trustees.

(XXXII) Any amendment or changes in Bye-laws of Trust should be made on 2/3 rd majority of executive Council.

(XXXIII) In the event of dissolution or writing up of the Trust the assets and funds remaining as on the dissolution shall under on circumst ances be distributed among the trustees/ members of the managing committee, members of the governing body but the same shall be trasferred to another charitable Trust, society, association or Institution whose objects are similar to this trust.

AIMS & OBJECTS OF THE TRUST

The aims and objects of the Trust of the Trust set out herein are for the benefit of the public and shall be as follows:-

- I. To establish & manage, Project to use non -conventional source of energy i.e. Solar Energy, Wind Energy, Gobar Gas Plants etc.

V. To estab. Training institute for primary, Bachelor of education & Master of education imparting instruction and training in banking, commerce, social services, village reconstruction work, small scale industries and such other subjects as may be determined from time to time.

(VI) To open, run and manage hospital, sanitorium, mobile dispensaries, maternity homes, leper's home, verterinary hospitals etc. for the treatment of disease or discover of human beings and animals.

(VII) To establish, manage and run training centres, treatment centres, rehabilitation centres, boarding houses etc. for physically and mentally handicapped.

(VIII) To float scholarship schemes and to give stipends, scholarships, loans and monetary aids to students, artists for pursuing their studies and other skills in the country and abroad.

(IX) To give stipends, monetary aids & financial assistance in the form of fellowship/ scholarship, prize/award/loan to exceptionally talented, meritorious, deserving and promising individual/studens/ artists/scholars/scientists/ social workers/ professional/ teachers/ administrators/ philanthrophists and other deserving individuals from any discipline for the furtherance of their career & future.

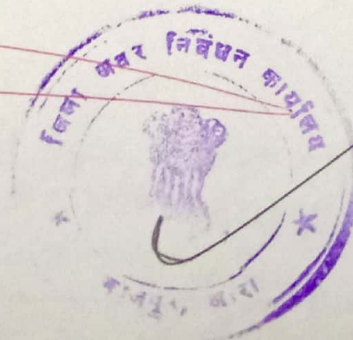
