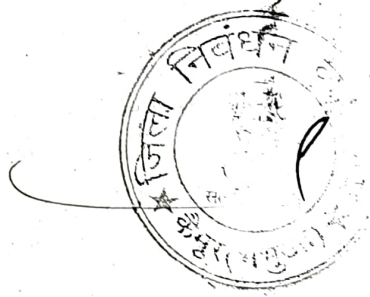

2. Now this Indenture Witnesses as Follows:

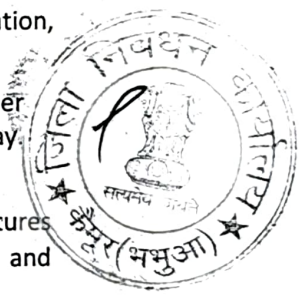

5. All the Income, earning, movable/immovable properties of the trust shall be solely utilized and applied towards the promotion of its Aims and objects only as set forth in the deed of the trust and no profit thereof shall be paid or transferred directly or indirectly by way of dividends, bonus, profits or in any manner whatsoever to the any person claiming through any one or more of the present or the past members. No members of the trust shall have any personal claim on any movable or immovable properties of the trust or make any profits, whatsoever, by virtue of his membership.

6. That the trust fund may be augmented by the income from the initial fund and also by donations and other contribution from time to time.

7. That the Trust fund shall not be applied for any purpose other than those specified in Para 3 herein above unless the other objects added to the trust objectives.

8. That the trustees shall always maintain proper accounts of the trust, which shall be kept at the office of the trust.

9. Subject to the provision of Income Tax Act. 1961 as amended from time to time, the trustees will keep the trust fund or such portion thereof, as they may, in their absolute discretion, think fit and proper, without being answerable or accountable to the beneficiaries or any other party for any loss invested in such share, stock, securities and debenture of acquisition or construction of any immovable property including buildings and/or in the purchase and acquisition or mortgage by way of fresh change on any immovable property in India, of free-hold or lease-hold tenure, and may deposit the amounts with any scheduled Bank, Company and private firm or Individual on such term and conditions as they think fit, In the matter of investment of Trust Funds, the provisions of section-20 of the event of Trustees purchasing any immovable property or properties or advancing moneys or mortgages, they shall be entitled to accept such title or evidence of title as they shall think fit in their absolute and uncontrolled discretion. The Trustees shall have power, if any deed it in their absolute to sell the Trust Fund or any part thereof and any such immovable property purchased by them under the power aforesaid and any other shares, securities, etc. and stand possessed of the money to arise from such sale upon after paying there out the expenses pertaining to such sale upon the trusts and with the subject to powers and provision including all the posers contained by and under these presents declared and contained concerning the Trust Fund which or the proceeds thereof, shall have laid out in purchase of property or properties as aforesaid or such of them as shall be then subsisting and capable of taking effect.

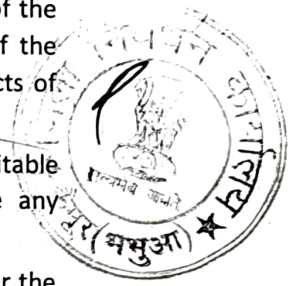

10. That for the furtherance of the objects of the trust, the trustees shall have the following powers:

- i. To accept any donation, contribution grant or subscription in cash or in kind, from any person(s) body of person or trust, with or without conditions.
- ii. To apply the whole or any part of the income of the trust, or the trust fund or accumulations thereto, to any one or more of the objects of the trust, as the trustees may, in their discretion, deem fit from time to time.
- iii. To open account in the name of the trust, with a Bank or banks, to operate such account and to give instructions to the Bank and to provide for opening and operation of such account by one or more of the Trustees or by an agent appointed by the Trustee.
- iv. To Adjust, Settle, compromise, compound refers to arbitration, all actions. Suits Claims, Demands and proceeding regarding the Trust Fund.
- v. To engage Or make provision for the engagement of any person(including all or any of the Trustees and Committees or administration or managing Trustees or Otherwise) for the purpose of the ~~administration of the Trust~~ in such rules and regulation as the Trustees may prescribe and also to engage or provide for the engagement.
- vi. To make, vary, alter or modify schemes, rules and regulations for carrying out the objects of the Trust and for the management of the affairs thereof and/or running any institution in furtherance of the objects of the trust and otherwise for giving effect to the objects of the Trust.
- vii. To start, abolish, discontinue and restart any charity of charitable institutions for the benefit of general public and to impose any conditions to any subscription or donation made by them.
- viii. to set apart and/or allocate the whole or a part of the income or the corpus of the Trust Fund or part thereof for any of the objects of the Trust.
- ix. To join, co-operate or amalgamate this trust with other or other having kindred or allied objects, upon such terms and condition as the trustees may in their discretion think fit, particularly having regard to and in conformity with the objects and nature of this Trust.

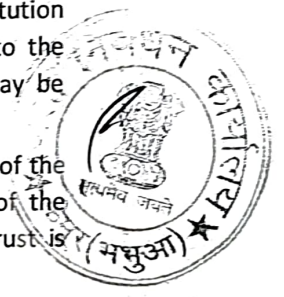

established or which may hereinafter be established for the like charitable purpose mentioned in these presents or any of them to enable such institution, societies, organisation or trustees to start maintain, or to carry out such charitable objects.

- xi. To settle all accounts and to compromise, abandon, or refer to arbitration any action or proceedings or disputes, claim, demand or things, as deemed proper for such purpose without being responsible for any loss occasioned thereby.
- xii. To borrow money either on the security of any property comprised in the Trust Fund or Otherwise for all or any of the purpose of these presents, and it shall be lawful for the Trustee to make such borrowing on payment of such interest and otherwise on such term and condition as they may in their absolute discretion think fit.
- xiii. To apply to government, public bodies, urban, local municipal, district and other bodies, corporation, companies, or person for and to accept grant of money and of aid, donations, gifts, subscriptions, affiliation and other assistance with a view to promote the objects of the trust and to promote the objects of the trust and to discuss and negotiate with the government Departments, public and other bodies, corporation, companies or persons, scheme and other work and matters within the objects of the Trust and to put to any proper condition upon which such grants and other payments may be made.
- xiv. To take over or amalgamate with any other charitable trust, trustee, association, or institution with similar objects,
- xv. To take over, acquire, manage, control or aid any existing institution or institution having objects either wholly or in part similar to the objects of this Trust and on such terms and conditions as may be thought expedient.
- xvi. To purchase or otherwise acquire and undertake all or any part of the property, assets, liabilities and engagement of any or more of the trusts, societies, institution or associations with which this Trust is authorised to amalgamate.
- xvii. 50% of saving of the institution run by the trust may be utilised by the trust to start another branch of the institution



11. The Trustees shall be accountable only for such money, and funds, which will actually come into their hands.

12. The Trustee will not be entitled to receive any remuneration, but the Trustee may reimburse themselves all expenses actually incurred by them in connection with the trust or their duties relating thereto.

13. The Managing Trustee for the time being will be at liberty to appoint additional Trustee within the number mentioned above for such period and such terms as to retirement and re-appointment as the trustee for the time being consider proper.

14. A person shall cease to be a Trustee either:

- If he without leave of absence does not attend three consecutive meeting of the Trustee or for one calendar year, whichever is long, or
- If he is requested to resign by 3/4th or as near thereto as possible of the remaining trustee.

15. Every Trustee will be at liberty to resign on giving one month's notice of his intention to do so.

The Trustee may from time to time frame rules for the conduct and regulation of the meeting of trustees. In the absence of such regulations:

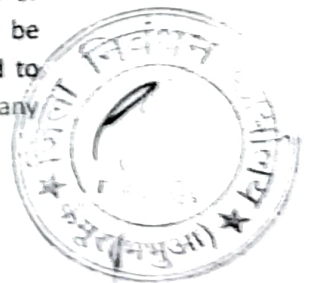
- a) The Trustee will meet quarterly every year.
- b) Five Trustees shall form a quorum for a meeting of the Trustees.
- c) All matters will be decided mutually by the Trustee.
- d) Resolution passed without any meeting of the Trustees but by circulation thereof and evidenced in writing under the hands of two thirds of the trustees shall be as valid and effectual as a Resolution duly passed at meeting of Trustees.

16. The Trustee shall have the power to determine in case of doubt whether any money or property shall for the purpose of the charity be considered as capital or income and whether out of Income or capital any expenses or outgoing ought to be paid or borne and every such determination shall be binding and conclusive provided that nothing contained shall be deemed to authorise the Trustee to spent the income or corpus of the Trust for any purpose not authorised by these presents.

17. The accounting year of the trust shall be the financial year ending 31st March of every year.

18. The Trust and trust Funds shall be irrevocable for all the times.

19. It is expressly declared that no part of the Trust property or its income or any accretion thereto shall be applied for any purpose outside India or for any purpose which is not a Charitable purpose in law, and all provisions hereof shall be construed accordingly.
